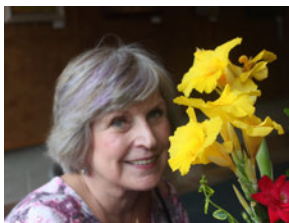

Change is good, but you will need to keep on top of it. Stay connected. Check your email. Check the BCAG website. Embrace what is unfamiliar to you. It is called progress.

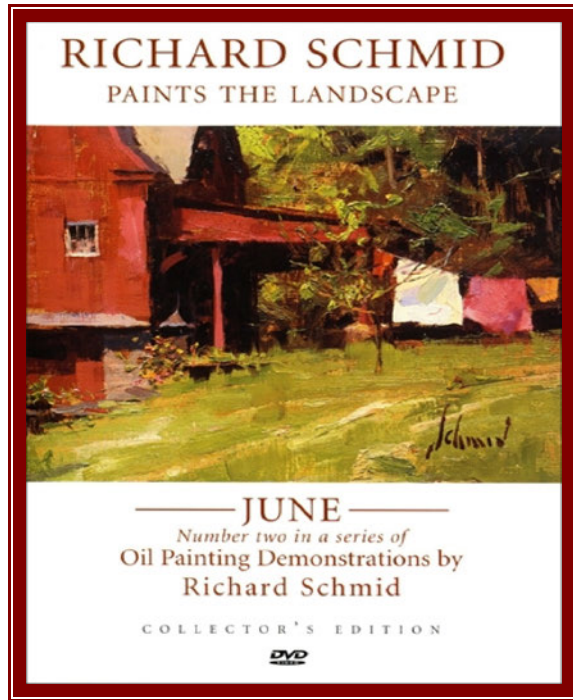
